S.S. "UALAN".

We are in receipt of your letter of the
2nd inst., and thank you for the information
contained therein.

We note your explanation regarding the
omission of the figure "1" for equipment from the
class of the above Steamer that the equipment
supplied was not equivalent to the requirements of
the Society's Rules. We were under the impression
that Anchors and Cables had been checked by your
Local Surveyor by Certificates on board. These
Certificates were handed your Local Surveyor
for this purpose and have not yet been returned.

We also note your statement that there
was no third Bower Anchor. We were informed
by your Surveyor at this Port that a third Bower
anchor, weight 8 $\frac{1}{2}$ cwt. ex stock, would be required
for this vessel to obtain figure "1". This was
immediately put on order and now awaits vessel at
this Port.

We shall be pleased to receive further
advice if this anchor is placed on board whether
this will meet with the requirements of your Society
to obtain the figure "1".
