Referring to the plan approved on the 8th instant of longitudinal bulkheads for whale oil of the steamer "N.T. NIELSEN-ALONSO" we beg to inform you that we have to-day received the following letter (translated) from the Framnæs mek. Verksted A/S:-

"Enclosed we beg to forward plans in triplicate showing proposal to strengthening of 8" channel steel stiffeners on the two longitudinal bulkheads in the after holds of this steamer.  
"We have at present a large stock of 8" channel profiles and beg that you will kindly consider this closely before you withhold your consent for the use of same."
