The Wellington Surveyor, who was authorised, now reports the ship placed on a floating dock, and the Special Survey (port & starboard) advanced and to complete same the side fuel oil tanks require to be examined and tested.

The bottom has been cleaned and coated, repairs and renewals effected to shell plating, deck, tank top, rigging and minor repairs carried out.
