Drillings at ends to be made in the vicinity of the peak bulkheads.

The class is subject to set up bar keel and shell plating being dealt with and internal wasted seam edges of shell plating in 'E' strake (p & s) being examined and dealt with as necessary by the next Special Survey, to permanent repairs to fire damage in after accommodation on the ship's arrival at a U.K. port, and to a bower anchor and 15 fathoms of chain cable being supplied at the earliest opportunity.

A General Examination for postponement of the Special Survey (D) which became due 10,51 until 3,52 has been carried out.

The NEWCASTLE Surveyors report the ship placed in drydock and a preliminary examination made with a view to obtaining a specification of repairs for the Special Survey.

Considerable renewals are recommended to the shell, deck, frames, etc. but these have not been carried out pending the Owners' decision regarding the future of the ship.

an appropriate Notation be inserted in the Register Book.


IT IS FURTHER SUBMITTED the ship is eligible
