This case has received the consideration of the Committee from time to time, and on the 13th ultimo the Aberdeen Surveyors stated that the position as regards the vessel was somewhat uncertain owing to the Owner having recently died. The vessel was to be sold, and the Superintendent stated that on account of her condition the vessel would probably be taken out of class. In the circumstances the Committee deferred action in regard to the case for a short time.

On the 3rd instant the Aberdeen Surveyors wrote to the effect that the Executors of the late Owner had not come to any decision with regard to this vessel, and on the 7th a communication was addressed from this Office to the Executors


stating that if the vessel was in commission arrangements must be made for the Special Survey in question to take place at once in order to entitle her to retain her class in the Register Book. It was added, however, that should the vessel be laid up the Committee would be agreeable to her retaining her class for a period of twelve months subject to the usual undertaking being furnished.

The following letter has now come to hand from Messrs. Brander & Cruickshank of Aberdeen, Viz:-

"Your letter of the 7th instant has been under consideration of the Executors of the late Mr. James G. Adam. The position is that we had expected to be able to expose this vessel for sale before now but there has been considerable delay in getting confirmation of Mr. Adam's estate. We expect to be in a position to sell this boat within the next four weeks and we shall of course keep your letter in view in making the sale.

In the meantime the vessel is at sea and although she is not doing particularly well it would suit the Executors better that she was actually fishing at the time of sale. If, however, it is essential that the vessel should be laid up in terms of your letter of 7th instant would you please let us know and we shall give the necessary instructions."

The Aberdeen Surveyors also state they have been unable to obtain any information regarding this case. They add that the vessel is still in commission and has recently been in port but that nothing has been done; also that they have been

informed by the Superintendent unofficially that he is quite sure the vessel will not be put through survey.
