We beg reference to various interviews we had with your
bodselves earlier in the year regarding this steamer, which,
according to Owner's contention, was withdrawn by you from
our class through a mistake on the part of your Bergen represent-
ative.

You will remember that, owing to your inability to see
our way immediately to reinstate her in class, she had to perform
a voyage with Lumber from GULF of MEXICO to RIVER PLATE unclassified;
owing to the fact that she was therefore technically out of class,
lumber charterers withheld a portion of the freight money on behalf
of shipper to cover any eventual extra Insurance on cargo.

Owners state that their Insurance policies on steamer were
unaffected and we ourselves held a policy against interest on steamer
which was also unaffected; Owners further state that the cargo was
delivered in good condition and to their knowledge no claims have been
presented by the Receivers. It would therefore appear unlikely that
shippers actually incurred extra Insurance on the cargo, but so far
they are still retaining the freight money which was deducted.

The object of the present is therefore, at Owners request, to
ask you under the circumstances, to issue a notice that there is no
extra Insurance involved on cargo for this voyage, *in order to assist them*
in recovering the withheld portion of their freight.
Trusting you may be able to see your way to comply with Owners'
request, and meantime apologising for having to trouble you.
