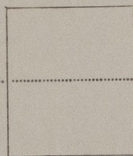

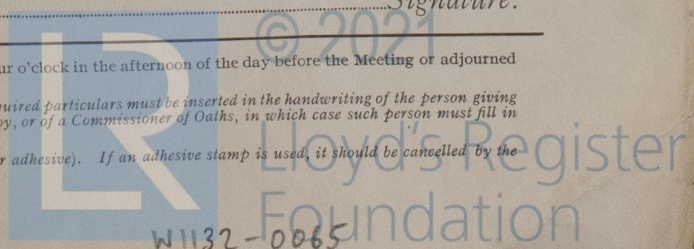

This Form of Proxy must not be filled in by the Liquidator. The required particulars must be inserted in the handwriting of the person giving the proxy, or of any manager or clerk or other person in his regular employ, or of a Commissioner of Oaths, in which case such person must fill in and sign the Certificate at foot.

The Form of Proxy must bear a Penny Stamp (either impressed or adhesive). If an adhesive stamp is used, it should be cancelled by the person giving the Proxy writing his name across it.
