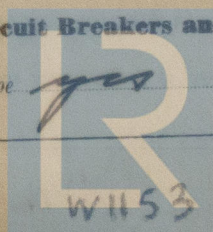

Joint Boxes, Section and Distribution Boards, is the construction, protection, insulation, material, and position of these as per rule *yes*  
Cables: Single, twin, concentric, or multicore *insulation* the cables insulated and protected as per Tables IV, V, X, XI, XII or XIII of the Rules *yes*  
If the cables are insulated otherwise than as per Rule, are they of an approved type *3 rolls* Fall of Pressure, state maximum between bus bars and any point of the installation under maximum load *3 rolls* Cable Sockets, are the ends of all cables having a sectional area of 0.04 square inch and above provided with soldering sockets *yes* Paper Insulated and Varnished Cambric Insulated Cables.

where are the controlling switches situated *outside of spaces*  
are all fittings suitably ventilated *yes* are all switches and lampholders constructed wholly of non-ignitable, non-absorbent materials *yes*  
Heating and Cooking Appliances, are they constructed and fitted as per Rule *yes* are air heaters constructed and fitted as per Rule *yes*  
Searchlight Lamps, No. of *one* whether fixed or portable *portable* are their fittings as per Rule *yes*

A cable carrying 20 Ampères 16 feet from standard compass 14 feet from steering compass.

A cable carrying 2 Ampères 6 feet from standard compass 6 feet from steering compass.

A cable carrying Ampères feet from standard compass feet from steering compass.

Have the compasses been adjusted with and without the electric installation at work at full power *yes* ✓

Has the effect of switching on and off circuits, motors and other electro-magnetic apparatus within the vicinity of the compasses been noted *yes* ✓
