The vessel being urgently required, and loaded, it was requested that temporary repairs be carried out at this port, subject to permanent repairs being effected at next docking.

In this connection, the bulwark plates were temporarily faired and part renewed, to permit using Starboard fairlead, a cement box being fitted in the forward frame-space of Fore Peak space in way of damaged deck plate &c. Air and vent pipes were faired temporarily.

All of the above temporary repairs were found satisfactory.

The steering gear telemotor pipes were drained and recharged with non-freezing solution as a precaution against further mishap, in view of the extremely low temperature conditions prevailing, the steering gear afterwards being tested under working conditions and found satisfactory.
