Two longitudinal bulkheads fitted.

On account of damage through striking quay wall shell plates G.4 & 5 and H.5 from aft and framing in way of boiler space (s.s) slightly indented. Temporary repairs have been effected and the Surveyors recommend permanent repairs at the Owners' convenience.

This vessel appears to have been built in accordance with the Rules and the approved plans, and it is submitted she is eligible to be classed LLOOA1 "Carrying Petroleum in bulk"

Subject to slightly indented shell plating & framing in way of boiler space starboard side being ~~represented~~ dealt with at the Owners' convenience.


