In reply to the above I have cabled you as follows:-

"Yes "Megohm" fuel installation is fitted in accordance Rules stop Flash point oil above one hundred and fifty".
The 2 oil fuel storage tanks and the one settling tank, fitted on board the vessel, were sent out from home. They were strongly constructed and electric welded throughout and when tested were found tight.

All other parts of the installation were all found to be in order and to the requirements of the Society's rules.
