Society's Register Book.


The Surveyor adds that he has had an interview with

The Classing Committee had the cases before them on Friday, 28th ultimo, when they decided to give instructions for the character of each vessel to be withdrawn from the Register Book and three dots (...) inserted in lieu thereof, indicating withdrawal of class at Owners' request.
