


Dear Sirs,

SS. "STYLIANOS COUTSODONTIS".

We beg to acknowledge receipt of your letter of yesterday and have noted with regret what you have, to the Committee's instructions, communicated to us in the same.

We, as you know, made two requests. The Committee have seemingly dealt with only one, that is re the retention of class. Either the shipowner nor ourselves could be expected to incur the heavy expense of putting the ship through survey before leaving Salina for the purpose referred to in our letter of the 31st ult. However, as the Committee have not seen their way to do what we requested in this connection, that is retention of class, we should be very pleased if you would kindly desire them to deal with the alternative request we made of them, which was as to whether they could not, as a favour to us and for the reasons we have already given you word of, see their way to tell the Society's Surveyor at the Piraeus that he may, having regard to what he reported in September 1932, grant the ship a certificate of seaworthiness which will allow of her leaving
