s.s. "Marie Moller"

We have for acknowledgment your letter of the 25th June, and regret very much the circumstances which compelled your Committee to expunge the s.s. "Marie Moller's" class from the Register Book with a Red Line.

We would explain that the s.s. "Marie Moller" is on Time-Charter to Messrs. Yamashita Kisen Kaisha, and the Time Charterers could not spare the vessel for any length of time. She was, therefore, hurriedly docked at Hikoshima, and your Society's Surveyor here in Shanghai was advised to this effect the day before she docked. It is regretted that the Kobe Surveyor could not attend, but in view of the fact that the Time Charterers were calling for the steamer, we could not possibly delay her in the drydock till the Surveyor arrived from Kobe after the urgent repairs had already been completed.

Whilst we appreciate the fact that your Committee have laid down certain rules and regulations, as practical Shipowners, we somehow feel that there ought to be a certain latitude in the interpretation of the same, because as you are aware circumstances sometimes arise which make it impossible for the Owner to hold to the exact letter of the rules and regulations.

We have been compelled regretfully to apply to the British Corporation for their assistance in this matter, and the vessel sailed from Miike on the 27th inst. with a British Corporation Register of Shipping & Aircraft's Provisional Certificate of Survey on board.

We have no critical comment to make against your Society, and we sincerely hope that your Committee will appreciate our view point in this matter.
