We have your communication of the 20th April 1936 enquiring what further definite arrangements have been made for the 2nd Special Survey No. 3 surrounding our s.s. "Marie Moller". We would advise you that the s.s. "Marie Moller" has about five months time charter to run with Messrs. Yamashita Kisen Kaisha. We have written to Captain R. Cordy, Master of the vessel, asking him to apply for an extension of his certificate at the first convenient Port - up to the present moment we have received no reply.

Perhaps you could kindly grant us an extension for a further period of five months, so that the vessel may complete her present time-charter, after which it is our intention that the vessel shall return to Shanghai and undergo the survey in question.
