REPAIRS, OR EXAMINATION AS PER RULE, FOR Permanent repairs.

This vessel having been placed in the No. 1 Dry Dock of the Harbour Works for the purpose of carrying out the permanent repairs recommended in my report No. 640, of 21<sup>st</sup> February last, I proceeded thereto, on the 14<sup>th</sup> August subsequent dates, to superintend same.

Stem having been removed was sent to shop to be straightened, and in the meantime the best of the rivets were removed and 7 plates taken out, 4 of which have been renewed and two cut between the 2<sup>nd</sup> and 3<sup>rd</sup> frames from bow, (as no new plates were available in Lisbon of the required length), of the following dimensions:—

1. 4'6" x 16'6" x 1/2" e. stroke; 2. 3'9" x 12'10" x 9/16" d. stroke, and
