No case can the ship be classed until all fees, travelling expenses, &c., due thereon are paid.

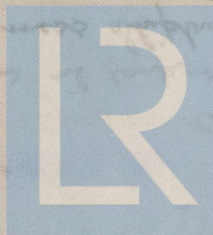
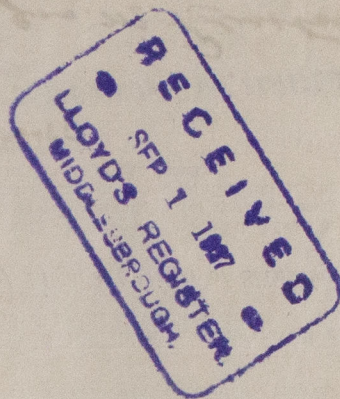
