Bushings of Nos. 1 and 2 rudder pintles fractured.

To be renewed in bronze.

Number of scattered shell and internal rivets loose and started.

To be renewed.

Stringer plates in forepeak fractured.

To be suitably cropped and part renewed.

Rivets in main engine, thrust and steering engine foundations started.

To be renewed.

Necessary removals and replacements in way of above repairs.

Necessary drydocking to effect repairs.

All new and disturbed work to be coated.

All tanks in way of damage to be tested on completion of repairs and proven tight.

The above recommendations made to place the vessel in the same good condition as before the damage was sustained have now been carried out to the satisfaction of the undersigned.
