Messrs. Swan, Hunter & Wigham Richardson Ltd.  
Engine No. 1606 - Yard No. 1567.

We acknowledge receipt of your letter of the 21st. instant and note that the plans of headers (C.1684/6/7) are approved, providing welding is carried out to the satisfaction of your surveyors.

We note that on Drawing C.1684/7 you have indicated in pencil the shoulder of one of the flanges thickened, and on Drawings MM.1858, MM.1859 and MM.1860, triplicate copies of which are enclosed, we have taken this into account and have made the diameter of the shoulder  $5\frac{3}{8}$ " instead of 5" as shown on the header drawing.

You will, by now, have received our letter of the 22nd. instant giving details of the header material. We take this opportunity of enclosing three copies of our order to T.Wards for the header material, and three copies of our order to Messrs. Tubes Ltd. for the additional tubing required. We assume that you will inform your local surveyors in each case regarding inspection.

We think it would be as well for your surveyor to visit our Works as soon after the Christmas Holiday as possible, so that the writer can fully inform himself as to your actual test requirements, and we would also suggest that during this visit your surveyor should stamp one or two pieces of tubing which we have arranged to have tested by one of the London Testing Engineers. Say, the West Ham Laboratory or Messrs. Kircaldys.

With regard to the safety valve, we note that the design put forward cannot be accepted, and we have written to the valve makers for alternative proposals.
