

Further to our recent correspondence in connection with the above, we have now received confirmation from Messrs. Tubes Limited that the tubing which we have in stock has been made by the "open hearth" process. We shall be glad to receive your confirmation by return that this tubing will meet your requirements.

The further tubing which we propose to order would be to a similar specification and upon receipt of your approval, will order immediately as we require an early delivery.

With regard to the boiler headers which are shown on our Drawings C.1684/5/7, (enclosed with our letter of the 16th. instant), we propose to manufacture these from the solid, and have received a quotation for a 5" diameter black mild steel bar made by the Siemens Martin open hearth basic process by Messrs. Appleby-Frodingham Steel Co.Ltd. The necessary certificates of tests etc. would be supplied and the material is subject to your surveyor's inspection.
