Dear Sir,

It is with pleasure that we acknowledge receipt of your letter of the 15th. instant and thank you very much for the information which you have given.

We note that your rules require the whole of the tubing to be of cold solid drawn steel, and have therefore amended our Drawing No. C.1684/3 to indicate material of this nature.

We are very anxious to commence tube bending immediately, and would mention that we have in stock approximately 1,800 ft. of suitable tubing which was purchased some time ago from Messrs. Tubes Ltd. through Messrs. International Combustion Ltd., this being left over from a contract which we carried out for them for Messrs. Aberdare Cables.

We enclose copies of Tube Makers' Certificates, also a copy of a test report covering various tests which were carried out by Messrs. Kircaldy to the requirements of the Vulcan Boiler and General Insurance Co. We have to-day written to Messrs. Tubes Ltd. asking them to confirm that the steel used for the tubing was made by the open hearth process, and we assume that in the event of our receiving their confirmation on this point, we shall be quite in order in using this supply.


With regard to the boiler headers, we enclose triplicate copies of our Drawings No.C.1684/6/7, and should be glad to receive your approval at the earliest possible moment.

We take this opportunity of noting that your local surveyors will get into touch with us regarding the necessary tests to be carried out.

Since dictating the above, we have had a 'phone conversation with your Office and understand that in view of the tubing shown on Drawing C.1684/3 now being supplied in cold drawn quality, you are agreeable to this being 12 gauge thick.


