

We are in receipt of a cable from The Michael A. Embiricos Shipping Corporation, dated New York the 16th March, 1942, reading as follows:-

"PIANGOS LLOYDS REQUIRES EXAMINATION CENTER
FURNACE PORT BOILER | ALSO GENERAL EXAMINATION
FOR GLASS AND FREEBOARD STOP IF ABSOLUTELY
NECESSARY ARRANGE ON SHIPS RETURN FROM AMERICA". |

Although the first word of the above cable is apparently mutilated, we transcribed this word to be "PIORGOS", who is the Captain of the Greek steamer "PAGASITIKOS".

This vessel recently left South Africa for South America, and eventual return to the Middle East.

The above quoted cable is self-explanatory, and we shall be pleased if you will kindly let us have your recommendations.
