We notice from the latest issue of Lloyds Register, which we  
we just received that the gross and net tonnages of the above  
vessel are described as being 4570 and 2630 tons respectively. We  
we have to inform you that the correct figures are, gross tonnage  
34.95, and net tonnage 2626.25. We shall be glad if you will  
kindly have this corrected as soon as possible, and also inform  
our various Agencies, more especially your New York branch.

A similar error incurred in the case of our "SILVERPINE"  
and we found that port dues, drydock dues etc, were being assessed  
on the wrong tonnages, and our Agents at New York had some diffi-  
culty in obtaining refunds of the overcharges, as the people con-  
cerned based their figures on the tonnages shown in the Register.

We notice also that in the list of "Shipowners and Managers"  
the "Silveray" is not included in the list of vessels managed by  
Stanley & John Thompson Ltd. We shall be obliged if you will  
kindly insert this vessel in the next issue in the list of vessels
