

are all fittings suitably ventilated yes, are all switches and lampholders constructed wholly of non-ignitable, non-absorbent materials yes

Heating and Cooking Appliances, are they constructed and fitted as per Rule yes, are air heaters constructed and fitted as per Rule yes



COMPASSES.

Distance between electric generators or motors and standard compass 130 feet

Distance between electric generators or motors and steering compass 130 feet

The nearest cables to the compasses are as follows:—

A cable carrying 14 Ampères 10 feet from standard compass 8 feet from steering compass.

A cable carrying 20 Ampères 12 1/2 feet from standard compass 12 1/2 feet from steering compass.

A cable carrying Ampères feet from standard compass feet from steering compass.

Have the compasses been adjusted with and without the electric installation at work at full power Yes

Has the effect of switching on and off circuits, motors and other electro-magnetic apparatus within the vicinity of the compasses been noted Yes

The maximum deviation due to electric currents was found to be 1/2 degrees on any course in the case of the standard compass, and 1/2 degrees on any course in the case of the steering compass.
