We are preparing Plans for the Orlop decks in No's 1, 3 and 4 Holds, and shall forward these on for your approval as soon as completed, but as scantling &c, of material will in each case be similar to that in No.2Hold your early approval of the enclosed print will enable us to arrange for ordering the bulk of the necessary material for all Holds as early as possible.

The preliminary plans were discussed the other day with your Mr.Gearing, and the enclosed are based on his suggestions.

The depth of new orlop deck beams are shewn 9" deep as being more readily obtainable than the 8½" originally intended.
