Particulars of Examination and Repairs (if any)

Is electric light and/or power fitted?..... If so, did the Surveyor examine the generators, motors, switchgear, cables and fuses?

Has the insulation resistance of the generators, circuits and apparatus been tested and found to be not less than 100,000 ohms?.....

If the Survey is not complete, state what arrangements have been made for its completion and what remains to be done.
