

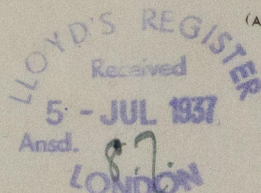

Dear Sir,

In answer to your letter dated 25th instant, concerning the First Entry Report N° 1759 (Chantiers de Normandie, Yard N° T-8) I cannot send you the original stamped plans, as they are in the hands of the builders, a copy of each being in my Office.

I telephoned to the Shipyard immediately on receipt of your letter and not getting satisfaction, wrote a letter to the Director intimating your desire.

They pretend that the original stamped plans should remain in their possession and until the present I cannot procure them although I have proposed to exchange the copies for the originals.

It is astonishing how they are making all sorts of trivial excuses and comparisons with the Bureau Veritas. Evidently they have no love for Lloyd's Register Classification and say so in very plain terms.

In reality they have lost money on the contract & Have not yet forgiven the Rouen-Surveyor for recommending the renewing of all the garboard strakes found cracked on port and starboard sides.

Enclosed, please find original letter from Shipyard dated 1st July 1937 signed by the Director, in which they say, in answer to my letter of the 29th June

"...It appears to us to be impossible to return you the plans in question as they are the only justification we have of them being approved by Lloyds Register.
