

T Dear Sir,

With reference to your letters of the 23rd instant respecting fees & taxes charged for the survey during construction etc. of the S/S "LEOPOLDVILLE", we regret that the fees & taxes mentioned in the Rough Fee Book & those shewn on the reports do not agree.

We have to explain that the tax of Frs. 2372 shewn on the 1st Entry Rpt. No. 16585 (hull) is the tax for the first three items mentioned on the enclosed copy of account rendered to Messrs. Cockerill. The difference of Frs. 275 between the tax shewn on this report & the tax shewn in the Rough Fee Book is the tax on the other items of the enclosed account. We notice that on the Electric Light & R.M.C. Reports the tax has been omitted. The late attendance fee & tax for same has also been omitted from the R.M.C. report, & we shall be glad if you will be good enough to correct these omissions. The fee & Tax of the Treeboard assignment should also be written on Rpt. No. 16328. The last item is a tax of Frs. 44 for the various classification certificates.

With regard to the fees & expenses charged on our Report 9 No. 16586, we have to state that these are already entered in the Rough Fee Book & you will find them in our transcript dated 30th



August A/C.1582. This account was given a number because at the time of rendering it, it was not known that a Report 9 would have been made out.

With reference to your letter regarding the sum of Frs.138180 paid into the Bank on the 20th instant, we have to state that the details of the items covered by this payment will be found on the above mentioned copy of account.

The total fees & expenses charged for the survey during construction of Hull & Machinery, Freeboard, Subdivision, Testing derricks, Electric Light installation, Refrigerating installation amount to Frs.165165.20. In addition to this there are fees for testing forgings & castings & separate a/cs. have been rendered viz:- A/C 1580 Frs.27859.40, A/C 1581 Frs.1277. There are also separate a/cs. for Machinery damage a/c.1582 Frs.964.60, also reported on Rept.16586 (Machinery), and Frs.912.60 hull damage report 16586(hull)

The total for all fees amounts to Frs.196178.80 of which 168281 has been paid, leaving 27897.80 Frs.outstanding. Messrs.Cockerill state a cheque for this amount will be forwarded.
