Dear Mr. Scott,

I am in receipt of your letter of the 24th instant regarding the non-payment of the fees of the s.s. "ZONNEWYK" and had the pleasure of entering into this case this morning with Mr. Dekkers Snr. & Jnr. to whom I explained your suggestions, but Mr. Dekkers Snr. did not like to pay the fees and claim upon the liquidators.

Both gentlemen being of opinion that Lloyd's Register should send in their claim as the Builders had requested the attendance of the Society's Surveyor, to obtain a class for the vessel.

Whilst I was present a reply was received to their letter and telegram as mentioned in my previous letter and it was similarly suggested to them to send in a claim for the fees but this was neither agreed to by Messrs. Dekkers.

The results of our discussion has led to an agreement that they will guarantee whatever the Builders should be short in paying the Society's fees, so that the vessel may be classed and in my opinion this will smooth all matters and meet Messrs. Dekkers who apparently felt rather dissatisfied. I am certain that in case your claim has no effect Messrs. Dekkers will pay the fees.
