Refrigerating Machinery for Motor Vessel being
built for the Blue Star Line Limited by Burmeister
and Wain, Copenhagen.
Their vessel No. 646.

We have contracted to supply a refrigerating installation for the above vessel for which your Society's Refrigerating Machinery Certificate is required. The vessel is being built at Copenhagen while the refrigerating machinery is being installed and insulation fitted in the vessel at a Shipyard on the Tyne.

The refrigerating installation consists of two separate units each having a pair of CO2 compressors bolted to and driven direct from the crankshaft of a four-cylinder vis-a-vis diesel oil engine of The Brush Electrical Engineering Company's manufacture, each unit having its own

CO2 condensers and evaporators, the cooling of the holds being performed in the usual way by means of grids and air cooling batteries with brine circulation and suitable pumps and distributing connections.

The inspection of the CO2 compressors and other parts is at our Works while the makers of the diesel oil engines, The Brush Electrical Engineering Co. Ltd., Falcon Works, Loughborough, who are sub-contractors to us, which engines will be direct coupled to the compressors, will arrange with you for the inspection of their engines at their Works and after installation on the vessel.

The brake horsepower and speed of each oil engine is 275 BHP. at 250 r.p.m.

The approximate insulated cargo capacity to which we are working for each vessel is about 609,000 cu.ft.

As regards the insulation, this is being carried out under a separate contract, as to which you will no doubt receive direct instructions.

When we were dealing with two generally similar installations in 1938 for the same Owners, i.e. "Wellington Star" and "Auckland Star", Messrs. Harland & Wolff's Nos. 1016 and 1017, we wrote to you on the 2nd September 1938 enclosing request forms with reference to the apportionment of your

fees, to which you replied on the 10th September 1938 as follows :-

- (1) Refrigerating Machinery Contractors .. £24. per ship.
- (2) Oil Engine Builders £34. for 2 ships.
- (3) Insulators £16. per ship.

"I am directed to point out, however, that the fee chargeable for the survey of the oil engines, viz. £34. does not cover any fees and expenses in connection with work which may be sub-contracted by The Brush Electrical Engineering Co. Ltd. elsewhere."

We assume for the present vessel that the fees would be as under :-

- (1) Refrigerating Machinery Contractors £24.
- (2) Oil Engine Builders £17.
- (3) Insulators £16.

the fees for the oil engines being exclusive of any fees and expenses in connection with work which may be sub-contracted by The Brush Electrical Engineering Co. Ltd. elsewhere.


We shall be glad if you will confirm that the same arrangement and apportionment of fees will obtain for the present vessel or inform us of any modification proposed.
