It will be observed from the above that the weights of the anchors are in excess of the Rule requirements.

The stud chain cable is 14 $\frac{2}{3}$ fms. shorter than required by the Rules, but is 1/16" greater in diameter and 7c 0q 23lbs heavier, and in view of this the length and weight of the cable is ~~was~~ submitted for favourable consideration.

The Surveyors should satisfy themselves with regard to the testing of the bower anchors, in view of the fact that no certificates for these have been forwarded.

It is submitted that as the stream and kedge anchors and stud chain cable have been tested by the Germanischer Lloyd

and the certificates produced and found to be in order, the same might be approved.

No stream wire is reported by the Surveyors to have been supplied.

The towline and hawsers are in excess of the requirements of Table 31.

It is further submitted that provided 45 fathoms of $2\frac{1}{4}$ " stream wire or equivalent be found on board or supplied, the equipment will be worthy of the favourable consideration of the Committee for the Figure 1, the notation of "Lloyd's A & C P" being withheld.
