


We have pleasure in forwarding you herewith prints of each of the following plans for your approval:-

We have been unable to complete the tail shaft as we have not yet received particulars of the propeller taper from the Makers. The diameter of the propeller will be 56".

Regarding item 14 Dr.No. 9983.M Bulkhead Stuffing Box suspending ring, we propose to use an oil resisting rubber composition for this purpose, to meet the wishes of the Owners, who desire to reduce any possible vibration to a minimum, we trust our proposal will meet with your approval.
