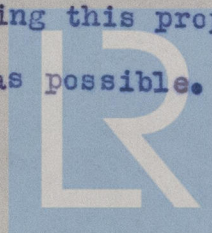
We beg to refer to approved Drawing No. 10650.S.

Shewing details of Cast Steel Stem proposed for the above Yacht.

We have asked several foundries both British and Continental for quotations, but are unable to obtain an offer, due we understand to the great difference in section of material in the two ends of the casting, and the comparatively long length and the risk thereby entailed in obtaining a sound casting.

We therefore propose to make the casting in two lengths, joined together at the butt by a double riveted strap on the inside, and the outside butt welded.

We enclose a print shewing this proposal and shall be glad of your concurrence as soon as possible.

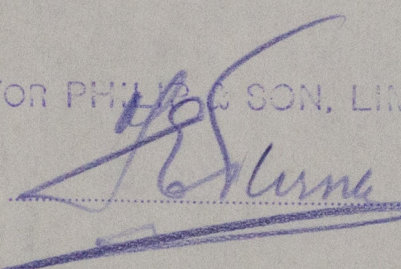
