Dear Sir,

New Twin Screw Motor Yacht No. 847.

We beg to refer to your letter of the 4th inst. and
to the drawing of the General Steel Work in particular.

In dealing with this plan you indicated that the side
frames in way of the windows in the deck saloon should extend up
through the main deck and terminate at carlings introduced below
the window openings. This is not practicable as these windows
are of the vertical sliding type, the operating gear of which
extends down to within a few inches of the deck.

We have discussed the matter with Mr. Norman Hart,
and if it is definitely considered that additional strength here
is desirable, we have agreed that in lieu of extending the frames
and subject to your approval, we increase the side plating from
6/20" to 7/20" thick in way of these windows. The frame angles

between the windows together with the reverse frames to extend right up as indicated.

We trust you are agreeable to this.

We also submit herewith the following plans in triplicate for your approval, viz:-

10669.S. Stern frame and rudder.

10663.S. Fresh water tank abaft of engine room.

10673.S. Fuel tanks, fresh water tank and ballast tank forward of engine room.

All these plans have been specially agreed with Mr. Hart and we shall be glad of your approval as soon as possible.
