

The 2nd S.S.No.3, became due 5,33 and a proposal to carry it same within the year of grace was agreed to.

A plate in the centre strake of trunk top required to be renewed at this Special Survey and welded plates in C and G strakes, starboard side require to be examined at the next drydocking.



The vessel which is a transversely framed tanker with a continuous shallow trunk above the upper deck is now under survey at Belfast. The Surveyors forward the results of the drilling of the shell plating amidships, in way of No.3 tank, port side and No.7 tank, starboard side, and at ends.

These results have been examined and compared with original scantlings and with scantlings determined in accordance with the present practice of the Committee in such cases and are considered to be satisfactory.

It is submitted the Surveyors be informed accordingly.
