Cables: Single, twin, concentric, or multicore **concentric** are the cables insulated and protected as per Tables IV, V, X or XI of the Rules **yes**

vessel has not been built under Special Survey but the electric units, fittings and appliances, cables and fastenings have been carefully installed on board in accordance with the Rules of the workmanship and materials throughout are satisfactory.

The undamaged electrical equipment has been megger tested throughout and placed in order.

Upon completion of the installation the entire electrical system was tested under full working load conditions and also in accordance with Section 21 of the Rules and found satisfactory. The three generators were paralleled, adjusted to normal voltage and the current breakers and governor gear tested out and found satisfactory. The spare gear conforms with the requirements of Section 22 of the Rules for Electrical Equipment.

In the opinion of the undersigned the electrical equipment is eligible to be classed and recorded.
