The class is subject to permanent repairs being effected to bow plating and framing at the first convenient opportunity and to the engine casing top being repaired at the Special Survey.

The 3rd Special Survey No. 1 due 11.37 has been commenced and the year of grace granted.

Some repairs are required to casing top and several plates just above the bilge, port and starboard sides, require to be drilled.

The vessel has been laid up and the usual undertaking was furnished.

With a view to extending the class for a period of 12 months from October last, a partial General Examination was carried out at Hull in November last, ~~and provided the examination be completed and favourably reported upon the desired extension has been agreed to.~~

Repairs are required to bunkers and to main deck plating and framing in way.

A further proposal for an extension of 12 months <sup>to date</sup> from the 25th <sup>recently</sup> January last has been agreed to provided the requisite repairs ~~can~~ be carried out.

The Hull Surveyors report the vessel afloat and the Special Survey advanced.

The vessel has also been generally examined and repairs effected to casing top, bunkers, framing, a number of hatch covers removed and other repairs carried out. *Defensive equipment has been fitted*

Two new wood deck houses have been erected on the bridge deck.
