

Cables: Single, twin, concentric, or multicore are the cables insulated and protected as per Tables IV, V, X or XI of the Rules

If the cables are insulated otherwise than as per Rule, are they of an approved type **Fail of Pressure, state maximum between bus bars and any point of the installation under maximum load** 2 V. alto. **Cable Sockets, are the ends of all cables having a sectional area of 0.04 square inch and above provided with soldering sockets** Yes **Paper Insulated and Varnished Cambric Insulated Cables.**
