Entry in Register. The above vessels have geared turbine machinery.

We understand that although we are the Machinery Contractors and have designed, manufactured and installed practically all the Machinery and Boilers for these vessels, our name will not appear in your register, as Column 13 is reserved for "Engine Makers Name", and that Messrs. Metropolitan Vickers Electrical Co., Ltd., Manchester, formerly British Westinghouse Electric & Manufacturing Co., (who actually made the Turbines only) will be inserted here, although they are our sub-contractors and have not supplied the Gearing or any other Machinery, their total being a small fraction, about 12% of the whole Engineering Installation.

Our original Contract with the Owners was for Geared Turbine Machinery of the Parsons type and this Machinery would have been entirely manufactured by ourselves. As the Owners subsequently desired to have "Westinghouse" Turbines, we agreed and endeavoured to come to an agreement with the British Westinghouse Electric & Manufacturing Co., Manchester who were the Licence Holders to enable us to manufacture Turbines of this type, but as we could not agree to their restrictions of our liberty to manufacture other types of turbines, we subcontracted the actual Turbine Parts only to them but made the Gearing and all other Machinery ourselves as usual.
