Dear Sir,

M. I have to inform you that deadweight and timber cargo freeboards in accordance with the International Loadline Convention Regulations are required to be assigned to the steamer "CHRISTIANSBORG". It is stated that this vessel is expected to arrive in New York on the 17th instant, and that the Owners' Agents are Messrs. Christensen, 11 Broadway, New York.

I shall therefore be glad if you will arrange for full particulars required on form C11 to be forwarded for re-assignment of freeboard in accordance with the above-mentioned Regulations.

A form giving all the available information extracted from the previous reports is enclosed, together with a few forms for the use of the Surveyors.

They should study carefully the requirements of the Convention as contained in the copy of the Report already sent to them, and in particular should note the requirements contained in the Section on timber deck cargoes, and make the necessary arrangements for these requirements to be
