Further to recent correspondence respecting the Survey of this vessel, we now beg to inform you that it has been decided to take the ship to Amsterdam for this purpose, after discharging her cargo at Liverpool.

We take this opportunity to ask that you kindly give the necessary instructions to your Surveyors at Liverpool, with a view to extending the ship's Freeboard Certificate to meet the above purpose. The present Certificate is a Provisional one for a voyage from U.S.A. to the U.K. or Continent via Cuba, issued at Baltimore on 25th May last. From the wording of this provisional certificate it appears that the ship will not be able to clear customs unless an extension is granted.

The ship will proceed to Amsterdam in ballast.
