

We are in receipt of your letter of the 5th inst. returning one copy of our plan of the rudder proposed for this vessel, and note your amendments.

Before proceeding with our working plan we wish to discuss the subject of rudder arms. We are not aware of any indication of your requirements in this regard except the dimensions given in table 43, where the breadth of the arm corresponds with the diameter of the rudder head. In submitting our plan for this vessel we made the width at the inner end less than the table, because we were fitting one arm more than required by rule. We note this is approved, but that our proposal to taper the arms to 8" at the outer end is not approved, and we cannot understand the reason for this. In our judgment when the arms at the stock are required to be anything above say 10" these if tapered would provide for better riveting attachment.
