The following conditions as laid down on Oslo letter of assignment dated 10th October 1932 have now been satisfactorily complied with: 1) All air pipes on weather and superstructure decks have been fitted with screw plugs permanently hung on pipes by guard chains. 2) Altogether 14 hatch covers renewed. 3) Steel angle carriers for fore & afters renewed: 1 on forward end coaming of No 1 hatchway. 2 on forward & 1 on after end coaming of No 2 hatchway. 2 on after end coaming of No 3 hatchway. 1 on second hatch beam from forward in No 3 hatchway & 1 on first hatch beam from forward in No 4 hatchway. 4) A number of cleats renewed. 5) Attention drawn to Rule 89 of Convention re. lashings.
