The 2nd S.S.No.1 became due 8,36.

The class is subject to the sternframe, E.W. repair 10,35, being further examined at the next dry docking and to indented shell plate D2 on port side being repaired at the Owners' convenience.

The Aberdeen Surveyors report the trawler placed on a pontoon, bottom cleaned and coated, the greater part of the Special Survey held, some steering chain renewed and minor repairs effected.

It is stated the Survey will be completed within the year of grace.

The sternframe E.W. repair and shell plate D2 (p.s.) as above examined and found efficient.

Shell plates A2 & B3 (port side) also found indented but efficient.

The Surveyors recommend the indented plating be dealt with at the Owners' convenience.

It is submitted action be deferred.
