

Dear Sir, LONDON

With reference to your letter of the 1st instant respecting the above named vessel I have to acquaint you that this vessel arrived here yesterday and I went aboard this morning to commence the survey of the re-assignment of freeboard.

I was informed by the Captain that he was discharging only part cargo here and the remainder at Leixões and is sailing tomorrow morning.

The vessel then proceeds to the Black Sea for a cargo of oil to discharge here and then is to lay up for three weeks early in July. The arrangements are that the vessel then proceeds to Alexandria for S.S., L.M.C. & Docking.

I informed the Captain that the B.S. was due in April and that he might suggest to the Owners that the B.S. be held here while the vessel is laid up and possibly part of the L.M.C. (M.S.) & S.S. might also be carried out.

Some measurements and particulars for the freeboard have been taken and the survey will be completed on vessel's return.
