As your goodselves may be aware, Messrs. Galban Lobo Co. S.A. are an important firm of sugar shippers in Havana, who entrust us with a considerable portion of their Marine and War Risk insurance requirements.

We have received the undermentioned cable from them, but ~~do~~ ^{did} not ourselves effect the Marine or War Risk insurance on the "Kafiristan" ^{S/} _S, and we anticipate that what they require is official confirmation of the Total Loss of the vessel.

"PLEASE ASK LLOYD'S GIVE THEIR HAVANA AGENTS INSTRUCTIONS BY CABLE TO ISSUE AND GIVE US CERTIFICATE OF WITHDRAWAL FROM REGISTER OF SS KAFIRISTAN DUE TO SINKING"
