**DESCRIPTION OF DYNAMO, ENGINE, ETC.**

One **3 1/2" x 3"** vertical enclosed steam engine with throttle governor capable of developing **5 1/2 B.H.P.** at **650 R.P.M.** with **120 lbs.** steam pressure direct coupled on extended bed-plate to **3 K.W.** compound wound dynamo.

Capacity of Dynamo **30.** Amperes at **100** Volts, whether continuous or alternating current **Continuous**

Main cable carrying **15.6** Amperes, comprised of **7** wires, each **18** S.W.G. diameter, **.0125** square inches total sectional area

Branch cables carrying **10.6** Amperes, comprised of **1** wires, each **16** S.W.G. diameter, **.0032** square inches total sectional area

Branch cables carrying **3.6** Amperes, comprised of **1** wires, each **18** S.W.G. diameter, **.0018** square inches total sectional area

Leads to lamps carrying **1.6** Amperes, comprised of **1** wires, each **18** S.W.G. diameter, **.0018** square inches total sectional area

Cargo light cables carrying **-** Amperes, comprised of **-** wires, each **-** S.W.G. diameter, **-** square inches total sectional area

**DESCRIPTION OF INSULATION, PROTECTION, ETC.**


Ship wired throughout with **Galenders. C.M.A. cable 2500 meg. and 600 meg. grade.** Cabin accomodation wired with **lead covered wire** and engine room wired with **steel armoured & lead covered wire.**

Joints in cables, how made, insulated, and protected **Loop in system used throughout no joints being used.**

Are all the joints of cables thoroughly soldered, and the flux used not containing acids or other corrosive substances **-** Are all joints in accessible positions, none being made in bunkers, cargo spaces, or spaces which may at any time be used for carrying cargo, stores, or baggage **-**

**VESSELS BUILT FOR CARRYING PETROLEUM.**

In vessels built for carrying petroleum, are all switches and fuses fitted in positions not liable to the accumulation of petroleum vapour or gas -

How are the lamps specially protected in places liable to the accumulation of vapour or gas -

The copper used is guaranteed to have a conductivity of not less than that of the Engineering Standards Committee's standard and the wires are protected by tinning from the sulphur compounds present in the insulating material.

Insulation of cables is guaranteed to have a resistance of not less than **2500** megohms per statute mile at 60° Fahrenheit after 24 hours' immersion in water, the test being made after one minute's electrification at not less than 500 volts and while the cable is still immersed.

The foregoing statements are a correct description of the Electric Light installation fitted by us on this vessel and we declare that it is at this date in good order and safe working condition.
