Dear Sir,

I am in receipt of your favour of the 20th instant, intimating that Messrs. McCowen & Gross, Ltd. are purchasing the Clan Line steamers "CLAN MACKELLAR" and "CLAN MACBRIDE" and that their names are to be changed to "MOORCOT" and "HEATHCOT" respectively, for which I thank you.

The "CLAN MACKELLAR" has been drydocked and in accordance with your letter an Annual Freeboard Survey has been held and the freeboard markings verified. These reports are enclosed together with the interim freeboard certificate and Load Line Certificate and certified copy for cancellation.

The Ash Shoot has been examined, and in my opinion is satisfactory meantime until the next Special Survey due in November, 1937. It has been arranged with the new Owner to have permanent repairs carried out at that time.

The vessel is leaving this port for Barry, South Wales, and the Owners desire to forward the Freeboard Certificates to the vessel there, and have requested us to arrange for these to be handed to their London Office, which is Leadenhall House, 101, Leadenhall St., London, E.C.3.
