be supplied, making the collective weight of the anchors  
55cwt. 0qr. 5 lbs., being equivalent to the Rule requirements;  
an additional 45 fms. of <sup>1 3/16"</sup> stud chain cable be supplied, making



the weight of the cable 173cwt. 2qr. 21 lbs., being slightly  
in excess of the Rule requirements; and 90 fms. of 4" warp  
be supplied, the vessel will merit the favourable consideration  
of the Committee for the notation Figure 1.

The matter of the equipment has been discussed  
in this Office with Mr. Zulver, the Owners' representative,  
who is agreeable to the above proposals, subject to the  
Committee's approval.
