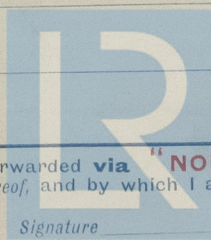

## CONDITIONS

On which this Telegram is accepted by the Company, or by the Postmaster-General, to be handed in at a Public Telegraph Office in the United Kingdom.

1.—Either the Postmaster-General or this or any other Telegraph Company or Foreign Government by whom this Telegram is or would in the ordinary course of the Telegraphic Service be forwarded, to forward the Telegram although it has been received for that purpose; but in such case the amount for transmission shall be refunded to the Sender at his request.

2.—Neither the Postmaster-General nor this nor any other Telegraph Company or Foreign Government by whom this Telegram is or would in the ordinary course of the Telegraphic Service be forwarded, is liable to make compensation for any loss, injury, or damage arising or resulting from non-transmission, delivery of the Telegram, or delay, or error, or omission in the transmission or delivery thereof, whatever cause such non-transmission, non-delivery, delay, error, or omission shall have occurred.

3.—This Telegram shall be forwarded in all respects in accordance with the provisions of the Acts made pursuant to the Telegraph Acts, 1863 to 1904, and the provisions of such Regulations shall be deemed to be binding not only between the Sender and the Postmaster-General, but between the Sender and this and any other Telegraph Company or Foreign Government by whom this Telegram is or would in the ordinary course of the Telegraphic Service be forwarded.
